

Who awards the Title CMC/BDU?

The International Council of Management Consulting Institutes ICMCI was founded to promote defined standards for management consultants. Meanwhile, this standard is recognized in 45 countries and more than 10.000 management consultants have been awarded Certified Management Consultants. The certification proceeding is worldwide coordinated. Each National Professional Body is regularly assessed to international audits. In Germany the institute IdU (Institut der Unternehmensberater), which is part of BDU, awards the title CMC/BDU.

Roles and Responsibilities of Institute IdU (Institut der Unternehmensberater)

- Awards the qualification Unternehmensberater CMC/BDU (Certified Management Consultant)
- Certifies the title Personalberater CERC/BDU (Certified Executive Recruitment Consultant)
- Patronage of academic research and traineeship of the profession and economic sector Management- and Recruitment Consultant
- Permanent education for Management- and Recruitment Consultants
- Standard wording for certain Consultants' responsibilities

Qualification as Management Consultancy BDU (Minimum qualification criteria for owner/manager)

- five years professional experience as Management Consultant
- thereof three years self-employed or management experience
- three excellent client references
- two structured professional interviews with BDU Management Consultants
- further details according client experience and satisfaction and personal reliance and trustworthiness

Professional Standards/Code of Professional Conduct

Objectiveness, neutrality, confidentiality when treating client information, fair competition and reasonable pricing – these are the main obligations for a Management Consultancy BDU. Ask for the BDU-Standards and attach them to your contract/statement of work!

Certified Management Consultant CMC/BDU

An internationally certified qualification is of particular value? In this case choose a certified management consultant CMC/BDU! CMC means Certified Management Consultant. Only Full Members of BDU can obtain the internationally recognized and individual title Certified Management Consultant CMC/BDU, awarded by the institute IdU (Institut der Unternehmensberater IdU), which is part of BDU, and are obliged to recertification every three years.

Qualification Criteria required to become a Management Consultant CMC/BDU

Only consultants meeting the following standard of competence are eligible for the individual qualification CMC/BDU:

- Three to eight years in management consulting according to professional qualification
- Proven permanent education of minimum 30 hours during the preceding year
- Structured professional interviews with two Certified Consultants CMC/BDU
- Written descriptions of three client references verified by consultant
